"The little town of Bassardon with fustian lovers, rare birds, bewildered mammals, magical trees, houses like open hearts and boat-like cars, has continued to pursue its contemplative journey among dreams that the artist shares with us. But this intimate choreography conquered continents of unpublished materials first - especially marouflages (a technique for affixing a painted canvas to a wall to be used as a mural), and bold mixed media - like the great beaches on black paper on the tank. The point of completion of the forms is done here, obviously, in the renewal of space and the construction of new structures - hence the symbolic figures still gain power of suggestion."

Renowned French artist born in Besançon, Pierre Bassard, made his debut in 1961 in Franche-Comté and in 1963 in Paris with the Group *Météros*. He was selected for the Fénelon Prize in Paris in 1966.

Since 1970, he produced numerous exhibitions both in Paris and the provinces and abroad. He participated in numerous exhibitions: the Ray Show (Salon de Ray), Drawing Show (Salon du Dessin), Engraving Show (Salon de la Gravure) in the National Paris Library, Corbell Show (Salon de Corbell), *Bilan de L'Art Contemporain* in New York, Figure Critique Show (Salon de la Figure Critique) in Paris, Salon des Amnésiades, and Triennales et Biennales in the Franche-Comté.

The artist has participated in the activities of the Groupe *Peindre et le Réel*, and the activities of the Collège de *Pataphysique*.
